MESSAGE FROM THE PRINCIPAL – GUIDELINE ENTERING MALAYSIA (STUDENT VISA)

As the Pandemic continues to affect travel around the world, I write to you to outline the latest guidance we have received regarding entry into or return to Malaysia during this particular phase of the RMCO. Further guidance is due to be relayed by the Government and the Immigration department by the end of August 2020, please find the latest information below.

In order to return to Malaysia, the Immigration department states the following SOP.

1. To start this process for parents and students who are currently under MIGS Visa to send an email to school requesting a student confirmation letter. Parents are also advised to send a passport copy with the relevant visa page(s) to school.
2. As Term 1 for the Academic Year 2020/21 is due to commence on the 1st September 2020, in order to complete any relevant quarantine periods, we recommend a return to Malaysia 2 or 3 weeks earlier than this date. students and parents are required to undergo mandatory quarantine for 14 days at a government-designated quarantine station.
3. Parents and students must inform the school of the date of arrival as soon as possible in order for the school to inform the immigration department in advance and obtain entrance approvals.
4. At least three days prior to departure parents and students will need to be screened (via a swab test) and provide proof of a negative result from their departure country. *This proof will need to be shown to immigration when entering Malaysia.* When entering Malaysia another test will be conducted by the Malaysian Immigration Department.
5. Parents and students will need to download My Sejahtera apps using a smartphone or similar device and complete all necessary information. *(Please note that this is a Compulsory step in the process)*
6. Sign the Letter of Undertaking and Indemnity (LoU) / *(Please note that this is a Compulsory step too)*

Parents and students who want to return to Malaysia need to download and complete LoU via the following link:

7. Should you be arriving from a country that requires visa to enter Malaysia, you must apply for this visa at your nearest Malaysian Embassy, High Commission or Consulate General in advance of entering Malaysia.

These are the most recent steps in order to enter Malaysia. However, I must remind parents that this only applies to our *MIGS Parents and Students who are under an MIGS sponsored Visa.* Whilst we can offer guidance for other parents and students, we are unfortunately unable to assist in the process.
